<p><a href="#">Form 1040</a> US Individual Income Tax Return</p>	<p>Annual income tax return filed by citizens or residents of the United States. <b>Related:</b> <a href="#">Instructions for Form 1040</a>, <a href="#">Instructions for 1040 Tax Table</a></p>
<p><a href="#">Form W-9</a> Request for Taxpayer Identification Number (TIN) and Certification</p>	<p>Used to request a taxpayer identification number (TIN) for reporting on an information return the amount paid. <b>Related:</b> <a href="#">Instructions for Form W-9</a></p>
<p><a href="#">Form W-4</a> Employee's Withholding Allowance Certificate</p>	<p>Complete Form W-4 so that your employer can withhold the correct federal income tax from your pay. <b>Related:</b> <a href="#">Withholding Calculator</a></p>
<p><a href="#">Form 9465</a> Installment Agreement Request</p>	<p>Use this form to request a monthly installment plan if you cannot pay the full amount you owe shown on your tax return (or on a notice we sent you). <b>Related:</b> <a href="#">Instructions for Form 9465</a></p>
<p><a href="#">Form 8962</a> Premium Tax Credit (PTC)</p>	<p>Use Form 8962 to figure the amount of your premium tax credit (PTC) and reconcile it with any advance payments of premium tax credit (APTC). <b>Related:</b> <a href="#">Instructions for Form 8962</a></p>
<p><a href="#">Form 4506-T</a> Request for Transcript of Tax Return</p>	<p>Use this form to order a transcript or other return information free of charge, or designate a third party to receive the information. <b>Related:</b> <a href="#">Form 2848</a></p>
<p><a href="#">Form 1040-EZ and 1040A</a> Income Tax Return for Single and Joint Filers With No Dependents <b>These forms have been deactivated and are no longer used.</b></p>	<p>Income tax return filed by certain citizens or residents of the United States. <b>Related:</b> <a href="#">Instructions for Form 1040-EZ</a></p>
<p><a href="#">Form 1040-ES</a> Estimated Tax for Individuals</p>	<p>Figure and pay your estimated tax on income that is not subject to withholding.</p>
<p><a href="#">Schedule A (Form 1040)</a> Itemized Deductions</p>	<p>Use this schedule to figure your itemized deductions. <b>Related:</b> <a href="#">Instructions for Schedule A (Form 1040)</a></p>


