Form W-9 Request for Taxpayer Identification Number (TIN) and Certification	Used to request a taxpayer identification number (TIN) for reporting on an information return the amount paid. Related: Instructions for Form W-9
Form W-4 Employee's Withholding Allowance Certificate	Complete Form W-4 so that your employer can withhold the correct federal income tax from your pay. Related: FAQs on the 2020 W4 form Related: Withholding Calculator
Form 9465 Installment Agreement Request	Use this form to request a monthly installment plan if you cannot pay the full amount you owe shown on your tax return (or on a notice we sent you). Related: Instructions for Form 9465
Form 8962 Premium Tax Credit (PTC)	Use Form 8962 to figure the amount of your premium tax credit (PTC) and reconcile it with any advance payments of premium tax credit (APTC). Related: Instructions for Form 8962
